Basic Application Information

Oklahoma Humanities (OH) is an independent, nonprofit organization whose mission is to strengthen communities by helping Oklahomans learn about the human experience, understand new perspectives, and participate knowledgeably in civic life through humanities disciplines such as history, literature, film studies, art criticism, and philosophy. As the state affiliate for the National Endowment for the Humanities, OH provides grants, a free educational magazine, Smithsonian Institution exhibits, reading and discussion groups, a podcast, and other cultural opportunities for Oklahomans of all ages.

Oklahoma's American Rescue Plan (ARP) Grant requests are intended to reach a diverse network of urban, rural, small, medium, and large sized organizations serving a myriad of important constituencies statewide. Oklahoma Humanities is providing recovery funding to museums, archives, historic sites, and other nonprofits impacted by the pandemic. Awards of up to \$15,000 will be awarded to prevent, prepare for, respond to, and recover from the coronavirus. The Oklahoma ARP Grants initiative funding was made available by the \$1.9 trillion American Rescue Plan Act of 2021 (ARP) approved by the U.S. Congress and signed into law by President Joseph R. Biden. Oklahoma Humanities is responsible for the distribution of federal funding allocated to the state of Oklahoma from the National Endowment for the Humanities Federal and State Partnership Division. To help ensure the recovery funding is spent quickly and project activities are conducted in a timely manner, all grant funds will be awarded by November 30, 2021 with a final report due by February 28, 2023.

There is no matching or cost share requirement tied to these funds.

What are the humanities?

"The term 'humanities' includes, but is not limited to, the study and interpretation of the following: language, both modern and classical; linguistics; literature; history; jurisprudence; philosophy; archaeology; comparative religion; ethics; the history, criticism and theory of the arts; those aspects of the social sciences which have humanistic content and employ humanistic methods; and the study and application of the humanities to the human environment with particular attention to reflecting our diverse heritage, traditions, and history and to the relevance of the humanities to the current conditions of national life."

Grant Applicant Requirements

- Organizations must serve and have headquarters in Oklahoma. Organizations outside of Oklahoma should contact the State Council in their area.
- Oklahoma Humanities is federally required to limit funding eligibility to U.S. nonprofit
 organizations with 501(c)(3) tax-exempt status, accredited public and 501(c)(3)
 institutions of higher education, state and local governmental agencies, and federally
 recognized Native American tribal governments. Individuals, foreign, and for-profit
 entities are not eligible to receive funding.
- Organizations must have a D-U-N-S[®] number. A SAMS (CAGE code) is strongly encouraged, but not required
- Organizations must agree to use the federal funding in a way that does not violate federal funding requirements
- Applicants must not have been federally suspended or debarred
- Applicants must not be delinquent on federal debt

Ineligible For Funding

- Individuals
- Public libraries
- For-profit organizations
- Organizations focused solely on the arts
- Political or advocacy organizations
- Universities, colleges, individual faculty members, and academic departments

(However, museums, archives, university presses and public-facing humanities centers affiliated with a college or university may apply for the Oklahoma ARP grants.)

Organizations with a strong arts focus are encouraged to contact the Oklahoma State Arts Council for grants provided through the National Endowment for the Arts. Public libraries are encouraged to contact the State Department of Libraries for more details.

NOTE: Programmatic expenses are not eligible under the Oklahoma ARP Grant funding stream. Applicants interested in pursuing programmatic grants should apply under our grants programs.

Especially Encouraged Applications

OH especially encourages applications from underserved communities that have been denied equitable treatment, such as Black, Latino, Indigenous and Native American persons, Asian Americans and Pacific Islanders, and other persons of color; members of religious minorities; lesbian, gay, bisexual, transgender, and queer (LGBTQ+) persons; persons with disabilities; persons who live in rural areas; and persons otherwise adversely affected by persistent poverty or inequality.

Allowable Costs

Grant funding may support general operating costs of humanities-focused organizations, including but not limited to: staff retention (payroll and benefits), facilities, insurance, and utilities.

Unallowable Costs

- Unallowable expenses as defined in 2CFR 200 Subpart E-Cost Principles
- Overlapping project costs with any other pending or approved application(s) for federal funding and/or approved federal awards
- Funds for activities supported by other non-NEH federal funds
- Competitive regranting
- Cancellation costs
- Costs dating to before March 15, 2021

- Equipment costs in excess of 20% of total project costs
- Travel (both foreign and domestic)
- Construction, purchase of real property, major alteration and renovation
- Environmental sustainability
- Collections acquisition
- The preservation, organization, or description of materials that are not regularly accessible for research, education, or public programming
- Promotion of a particular political, religious, or ideological point of view
- Advocacy of a particular program of social or political action
- Support of specific public policies or legislation
- Lobbying
- Projects that fall outside of the humanities and the humanistic social sciences
